General

1. The Services shall be provided only on submission of valid Digital CAF or hard copy of CAF along with POI & POA (as stipulated under the guidelines published by the Department of Telecom from time to time) & after verification of the information provided in the CAF by the subscriber, UCN will make best efforts to provide the services to the customer within the services area subject to the technical feasibility.
2. Usage includes both upload and download of data.
3. The data rates shown as down streams or upstream are applicable only to the last mile. However UCN does not hold responsibility for lesser/access download or upload data caused by the accessed website status or the international gateway or the media.
4. All IP-Addresses assigned will be dynamic.
5. Shifting of connection will be subject to the technical feasibility & would be done on payment of the applicable shifting charges.
6. UCN has the sole right and discretion to revise the Charges at any time on reasonable notice to the customer delivery in such manner as UCN deems fit.
7. UCN reserve the rights to initiate appropriate legal proceedings in case of breach of any of these terms and conditions by the Customer.
8. UCN may, without any notice refuse, curtail, modify, suspend, disconnect or terminate the Services in whole or in part at any time if so directed by the Authorities, without assigning any reason whatsoever.
9. No migration is allowed to the lower/higher tariff plan till the expiry of committed period.
10. Migration to the lower plan may cost extra to the customer.
11. The customer shall be responsible for using the service only for Legal and appropriate purpose.
12. Subscriber using Internet service in the name of Company, Shop, Firms, Educational Institute, or any Commercial entity can be given only Business Plan. They are not eligible for Home Plans
13. UCN reserves the right to disconnect the service to any customer in case
 - A. There is sufficient evidence of the customer intentionally or unintentionally using the service in manner which would adversely impact UCN or UCN's Network.
 - B. Non-payment of bills preferred by UCN in accordance with the tariff plans opted by the customer and the extent of usage or any default on the part of customers.
14. In case of service discontinuation the subscriber shall compulsorily return all the Goods in working condition which was provided by UCN. In the event of subscriber not being able to return the modem/devices to the company would charge to the subscriber.
15. "Router" and "Cable/Fiber" and "ONU" is the property of UCN. If customer don't recharge the account for more than 45 days then "Router" and "Cable/Fiber" and "ONU" will be recover from customer place.
16. Security deposit will not be refunded or adjusted if customer disconnects the services within the scheme period.
